IMPORTANT RULES AND POLICIES WHILE AT THE UNDER THE RAINBOW HOME DAYCARE

Certain rules and policies have been established for the Under The Rainbow Home Daycare which are essential to the safety and smooth functioning of this facility. These rules also ensure that every child feels comfortable and have fun while at the Under The Rainbow Home Daycare. The rules are taught to the children and need to be reinforced by the parents/guardians. Rules still apply even if the parents/guardians are present.

- First and foremost respect the daycare provider.
- Please behave in a nicely manner.
- Respect all daycare toys and equipment and not abuse them. Parents will be responsible for the cost to replace the toy if this should happen.
- Play together and respect others with no pushing, grabbing, kicking, spitting or biting.
- Please no running, jumping or screaming inside the home daycare.
- Please no roughhousing, climbing on one another or lifting or carrying other children.
- Please do not stand on or climb on any toys, tables or furniture.
- Please no name calling or teasing other children.
- No chewing gum is allowed in the daycare.
- LAUGH, SMILE, PLAY, AND BE HAPPY.

Respect for each other will be taught and adhered to at all times while at the Under The Rainbow Home Daycare. If the child is misbehaving during the play/activity, the child will be redirected to another activity and given an opportunity to try again at another time. On the occasion that the child is out of control and the daycare provider is unable to discipline them, you will be asked to come get your child. In this case the parent/guardian will not be reimbursed for the time the child is not at the daycare. I will work with the parents/guardians on this. Child’s unacceptable behaviour can also result in giving the child a notice for termination. (Above mainly applies to the older children, not to the infant and toddlers)
